

## Promotion Terms and Conditions – Win a Ford Ranger with Incedo promotion

## **Promotion, Promoter and Promotion Period**

- 1. The "Promotion" is the "Win a Ford Ranger with Incedo promotion".
- 2. The Promotion is being run by ASSA ABLOY Australia Pty Limited (ACN 086 451 907) of 235 Huntingdale Road Oakleigh Victoria 3166 ("**Promoter**").
- 3. The Promotion commences at 12am AEST Wednesday 30 August 2023 and runs until 12am AEST on Saturday 30 March 2024 ("**Promotion Period**").

### **Eligibility for entry**

- 4. Entry to the Promotion is open to any business (other than the Promoter or related bodies corporate of the Promoter) that, during the Promotion Period:
  - (a) is a registered business in Australia with an Australian Business Number (ABN) or Australian Company Number (ACN);
  - (b) has a trading account with the Promoter;
  - (c) either:
- (i) offers locksmith services and employs one or more locksmiths with professional accreditation or certification: or
- (ii) has a Private Security Business Registration in at least one or more States or Territories in Australia,

and a business that satisfies these requirements is referred to in the remainder of these Promotion Terms and Conditions as an "Eligible Entrant".

### How to enter

- 5. To enter the Promotion, an Eligible Entrant must, during the Promotion Period:
  - (a) purchase from the Promoter, and pay for in full, Eligible Products to the value of a minimum of \$1,000 GST-exclusive ("Minimum Spend"), where "Eligible Products" are the products listed in the Schedule to the Promotion Terms and Conditions:
  - (b) unless each of the following steps have already been completed in relation to the Eligible Entrant before the Promotion Period (in which case they are not required to be repeated during the Promotion Period):
    - (i) include the following in its purchases from the Promoter:
      - (A) the INCEDO TRAINING KIT HARDWARE; and
      - (B) either the:
        - ONLINE INCEDO LITE TRAINING (NO HARDWARE.1 PARTICIPANT); or
        - ONLINE INCEDO CLOUD TRAINING (NO HARDWARE,4 PARTICIPANTS) ("Incedo Training"); and
    - (ii) ensure that at least one of its employees successfully completes (passes) the Incedo Training;
  - (c) access the URL <u>assaabloy.com/au/en/incedo-ford-ranger</u> ("**Promotion Webpage**") and manually enter all of the required details (such as business representative name and contact information) to register entry in the Promotion, ensuring those details are valid and the Eligible Entrant only registers their entry in the Promotion once.
  - and be willing, if they are the Prize Draw Winner (as defined in section 10 of the Promotion Terms and Conditions) to fulfil the obligation on the Prize Drawn Winer set out in section 22 of the Promotion Terms and Conditions to assist the Promoter to obtain and to be able to use in marketing, one or more photographs of Installed Incedo Products.
- 6. All persons who access the Promotion Webpage and attempt to submit an entry or information via that page are deemed to have accepted the Promotion Terms and Conditions on behalf of the relevant Eligible Entrant.

## **Prize Draw Entries**

- 7. Subject to sections 8 and 9 of these Promotion Terms and Conditions, each Eligible Entrant who fulfils the conditions of entry for the Promotion set out in section 5 and is compliant with the other Promotion Terms and Conditions, is a "Participating Entrant" who will receive one Prize Draw Entry. A business can only be a single Participating Entrant, but as set out in section 8 of these Promotion Terms and Conditions that single Participating Entrant may qualify for more than one Prize Draw Entry.
- 8. Subject to section 9 of these Promotion Terms and Conditions, for each additional \$1,000 GST-exclusive (over and above the Minimum Spend) of Eligible Products purchased by a Participating Entrant from the Promoter during the Promotion Period, the Participating Entrant will receive an extra Prize Draw Entry.

## Opening Solutions

- If a Participating Entrant purchases \$1,500 worth of Eligible Products in the Promotion Period and otherwise meets all of the requirements set out in the Promotion Terms and Conditions, that Participating Entrant will have one (1) Prize Draw Entry.
- If a Participating Entrant purchases \$2,500 worth of Eligible Products in the Promotion Period and otherwise meets all of the requirements set out in the Promotion Terms and Conditions, that Participating Entrant will have a total of two (2) Prize Draw Entries.
- If a Participating Entrant purchases \$3,000 worth of Eligible Products in the Promotion Period and otherwise meets all of the requirements set out in the Promotion Terms and Conditions, that Participating Entrant will have three (3) Prize Draw Entries.
- 9. Where any Eligible Products purchased by a Participating Entrant during the Promotion Period are returned to the Promoter before the date of the Draw referenced in section 10 of the Promotion Terms and Conditions, and some or all of the value of those Eligible Products is refunded or reimbursed by the Promoter, that value will not count for the purposes of either section 5 (re Minimum Spend) or section 8 (re extra Prize Draw Entries) of the Promotion Terms and Conditions.

#### **Prize Draw**

10. A single prize draw will be conducted at midday (EST) Monday 3 June 2024 at the Promoter's offices at 235 Huntingdale Rd. Oakleigh, Victoria to select a single winner of the Promotion. That single winner will be the business whose Prize Draw Entry is drawn electronically, at random, from a draw that includes all of the Promotion's Prize Draw Entries ("Draw"). An independent scrutineer will be present at the Draw. The winner from the Draw will be the "Prize Draw Winner", subject to all of the Promotion Terms and Conditions. For the avoidance of doubt, no additional or bonus prizes will be awarded – the single Prize Draw Winner will be the only recipient of a prize.

#### **Prize**

- 11. Subject to section 12 of the Promotion Terms and Conditions, the Prize Draw Winner will receive the following "**Prize**": A Ford Ranger XLS (2024MY) 2.0L Bi-Turbo Diesel 10AT Part-Time 4x4, Double Cab Pick-up with Tech Pack and Tough Bed Spray-in Bedliner valued (as at 17August 2023) at \$61,500 (GST-incl) in Arctic White, to be supplied via the Brighton Ford dealership located at 63 Nepean Highway, Elsternwick, Victoria 3185 ("**Specified Dealership**"). The prize does not include any insurance in relation to the vehicle, or any accessories not specified. Any additional on-road costs including registration will need to be borne by the Prize Draw Winner.
- 12. To claim the Prize, the business that is the Prize Draw Winner must have complied with all of the Promotion Terms and Conditions and:
  - (a) have a representative of the business (who is at least eighteen years of age and licensed to drive a
    motor vehicle) attend the Specified Dealership on a date agreed between the Promoter, Prize Draw
    Winner and Specified Dealership, which date must be within 4 weeks of the Draw ("Prize Handover
    Period");
  - (b) provide all information and sign all documents required to allow the Promoter to register the vehicle in the business name before collection; and
  - (c) be able to register and operate the vehicle in the business name in accordance with applicable laws.

### Notification of prize winners

- 13. The Prize Draw Winner will be:
  - (a) contacted by a representative of the Promoter (via the phone number or email the relevant business supplied in its inputs to the Promotion Webpage when it registered entry in the Promotion); and
  - (b) published on the Promoter's website and/or social media channels, within 72 hours of the Draw.
- 14. If the Prize is not claimed by the Prize Draw Winner in the manner set out in section 12 of the Promotion Terms and Conditions within 4 weeks of the Draw, that Prize Draw Winner's entitlement to the Prize will cease and the Promoter will hold a redraw (to be conducted in the same manner as the prior draw) at midday on Monday 8 July 2024 to draw a replacement Prize Draw Winner (in relation to which all of the same processes and requirements will apply).

## Transportation and "as is" basis of prize

- 15. The Prize Draw Winner is responsible for the transportation of the Prize away from the Specified Dealership, including to any different State or Territory as sought by the Prize Draw Winner. Any additional costs incurred by the Prize Draw Winner from such transportation are the responsibility of the Prize Draw Winner.
- 16. To the extent permitted by law, the Prize Draw Winner takes the vehicle Prize on an "as is" basis, and the Promoter makes no representations or warranties in relation to the Prize that are not expressly stated in



these Promotion Terms and Conditions. The Promoter will not be responsible for any costs associated with maintenance, operation, fault, damage incurred during transport, damage incurred after collection, or any other costs relating to the Prize that the Promoter does not expressly agree to be responsible for in these Promotion Terms and Conditions.

### Other terms and conditions

- 17. The Promoter accepts no responsibility for any tax implications that may arise for the Prize Draw Winner from winning the Prize. Independent financial advice should be sought. The Promoter is not liable for any loss or damage whatsoever which is suffered (including but not limited to indirect or consequential loss) or for any personal injury suffered or sustained relating to the Prize except for any liability which cannot be excluded by law.
- 18. The Prize must be taken by the Prize Draw Winner as stated and is not transferable to another person or business, or exchangeable for other goods and services, and cannot be taken as cash.
- 19. If for any reason the Prize is not available in the Prize Handover Period, the Promoter will substitute it for another prize of equal or higher value (in the Promoter's discretion) subject to any required regulatory approval.
- 20. By entering the Promotion, the entrant (including the Prize Drawn Winner) assigns to the Promoter all right, title and interest in all Intellectual Property Rights that the entrant holds both past, present and future of whatsoever nature in and to the entry they have submitted with no rights to any additional compensation, reward or financial entitlement. The entrant's name may be used in several printed and web based publications.
- 21. The Prize Draw Winner agree to the use of the entry either in whole or in part as well as the entrant's (and the entrant's key business representatives') name, and photograph for publicity and promotional purposes, including for television, film, internet, radio and other forms of media as required by the Promoter without entitlement to any additional compensation, reward or financial entitlement. Entrants agree that the Promoter may modify any entry as it sees fit.
- 22. The Prize Draw Winner must, if requested by the Promoter, use best efforts to assist the Promoter to obtain and to be able to use in marketing, one or more photographs of Installed Incedo Products, including by taking any reasonable steps requested by the Promoter to obtain consents from the relevant third party. In this context, "Installed Incedo Products" are Eligible Products the Participating Entrant has purchased from the Promoter during the Promotion Period and subsequently installed at a relevant third party site.
- 23. In these Promotion Terms and Conditions, words in the singular include the plural and vice versa.
- 24. By seeking to enter the Promotion, each entrant warrants that any entry they submit will not be submitted in a manner that, or contain content that, violates any applicable law or regulation, and acknowledges that any non-conforming entry or failure to comply with the Promotion Terms and Conditions will render them ineligible to be a Participating Entrant.
- 25. Personal information ("PI") relating to each entrant, such as the name and contact details of a relevant business representative, will be collected so as to enable the Promoter to administer and promote the Promotion, its winner and any entrants. If entrants do not supply the PI they cannot enter the Promotion. In relation to the Prize Draw Winner, the relevant PI may be provided to other persons or businesses assisting the Promoter, including media and the Specified Dealership.
- 26. Entrants may contact a representative of the Promoter at <a href="info.au@assaabloy.com">info.au@assaabloy.com</a> to request access to any of their collected PI that is still held.
- 27. Entrants understand that they may be approached to be interviewed by media in relation to the Promotion in the lead up to, during and/or after the Promotion.
- 28. If requested by the Promoter, a representative of the Prize Draw Winner must participate in all Promotion activity (such as publicity and photography) surrounding the winning of the Prize, free of charge. The Prize Draw Winner must obtain the consent of relevant senior business representatives of that business to the Promoter using their name, likeness, image and/or voice (including photograph, film and/or recording of the same) in any media for an unlimited period without compensation for the purpose of promoting the Promotion), and promoting any products manufactured, distributed and/or supplied by the Promoter.
- 29. To the extent permitted by law, the Promoter and its respective employees and agents and related bodies corporate, the suppliers of the prize and their employees and agents and related bodies corporate shall not be liable for any claims, losses, damages, injuries, costs and expenses suffered, sustained or incurred (including but not limited to indirect or consequential) as a result of, or arising out of, or in any way connected with this Promotion and/or any Prize.
- 30. The Specified Dealership is not connected with the Promotion in any way, other than being the dealership through whom the Promoter is organizing for the Prize to be made available for supply to the Prize Draw Winner.
- 31. If for any reason the Promotion is not capable of running as planned, including infection by computer virus, bugs, tampering, unauthorised intervention, fraud, technical failures, acts of terrorism, or other causes beyond the control of the Promoter which corrupt the administration, security, fairness, integrity

or proper conduct of this Promotion, the Promoter may (to the extent permitted by law) adjust any necessary elements of how the Promotion is run in order to allow (the adjusted) Promotion to proceed. The Promoter reserves the right, in its sole discretion, to disqualify any individual who tampers with the entry process, and, to cancel, terminate, modify or suspend the Promotion.

- 32. WARNING: ANY ATTEMPT TO DELIBERATELY DAMAGE THE PROMOTION WEBPAGE OR THE INFORMATION ON THE PROMOTION WEBPAGE, OR TO OTHERWISE UNDERMINE THE LEGITIMATE OPERATION OF THE PROMOTION IS A BREACH OF THESE TERMS AND CONDITIONS AND MAY BE A VIOLATION OF CRIMINAL OR CIVIL LAWS AND, SHOULD SUCH AN ATTEMPT BE MADE, WHETHER OR NOT SUCCESSFUL, THE PROMOTER RESERVE ITS RIGHT TO SEEK DAMAGES TO THE EXTENT PERMITTED BY LAW.

  - (c) performers protection;
  - (d) moral rights;
  - (e) inventions (including patents);
  - (f) trade marks, service marks and the like;
  - (g) designs and software; and
  - (h) any other intellectual property as defined in Article 2 of the World Intellectual Property Convention of July 1967, whether or not existing at the date of submission by the entrant of the entrant's entry to the Promotion and whether or not registered or registrable and includes any right to apply for the registration of such rights and includes all renewals and extensions including all rights of a copyright owner as at the date of the entrant entering the Promotion and all additional and/or modified rights recognised or created by the Copyright Amendment (Digital Agenda) Act 2000.
