New manipulation method affecting 3 star cylinders certified to the TS007-01 standard

Product Security Advisory

Overview

We have become aware of a new manipulation method which affects 3-star cylinders certified to the TS007-01 standard.

Advisory Status

Our 3-star cylinders comply with the current TS007 standard for 3-star certified cylinders and provide a high level of security. However, we have been made aware that these cylinders can potentially be manipulated, and that this issue most likely affects all 3-star cylinders certified to the TS007-01 standard from all manufacturers selling into the UK market.

It is important to note that a successful manipulation attempt would only be possible by a person possessing malicious intent, in addition to having the requisite skills, knowledge and necessary equipment.

Having spoken to police authorities, we can confirm that to our knowledge, there has been no instance where the manipulation method has been successful in the field.

Affected Products

Having spoken to police authorities the affected products are as follows:

- Yale Platinum 3 star euro profile cylinder
- Mul-T-Lock MTL300 Breaksecure 3XP euro profile cylinder
- Mul-T-Lock Integrator Breaksecure XP 3-Star euro profile cylinder

Enhanced Security

The Yale Platinum 3 star, Mul-T-Lock MTL300 Breaksecure 3XP and Mul-T-Lock Integrator Breaksecure XP 3-Star euro profile cylinders have been tested and accredited to the current Door & Hardware Federation (DHF) Technical Specification TS 007:2014+A2:2018 3-star classification.

However, should you want to enhance your home security even further installing these euro profile cylinders with a handle or escutcheon that is clearly marked as meeting the TS 007:2014+A2:2018 2-star classification has been shown to provide additional protection against unlawful criminal entry.
